REVISED SCHEDULE FOR APPLICANTS HOLDING AN APPOINTMENT FOR PASSPORT RENEWAL FROM JUNE 1 TO 4, 2021 AT DFA-ASEANA, OR, AT VARIOUS CONSULAR OFFICES IN THE NATIONAL CAPITAL REGION (NCR), ANTIPOLO, DASMARIÑAS, MALOLOS OR SAN PABLO

In view of the return to General Community Quarantine status, with heightened restrictions, in these areas, and with the need to attend to applicants affected by the Modified/Enhanced Community Quarantine this April-May 2021, **your appointment has been rescheduled. Please be guided by the following tables to determine your new schedule:**

Example: If your original schedule is on June 1 and your surname starts with the letter 'C', your new schedule is on July 7, and you may visit between 10 a.m. to 12 noon. If your original schedule is on June 1 and your surname starts with the letter 'Y', your new schedule is on July 8, and you may visit between 2 p.m. to 4 p.m.

You will not be accepted for processing if you report on the original date of your appointment.

Please bring a print-out of this email, your application form indicating the original appointment schedule, your e-receipt, and your supporting documents.

Please note that the schedules may be subject to sudden changes due to unforeseen circumstances or changes in the policies of local governments and mall partners which host these COs. The DFA will update its advisory if there are changes to the schedules. Please regularly check our website <https://consular.dfa.gov.ph> for updates on our CO operations.

Anyone entering our COs has to consent to a temperature check prior to entry. While inside CO premises, everyone must follow all public health measures currently in place, including use of a mask and a face shield. Only one companion will be allowed for elderly applicants/ PWDs requiring assistance/ minors/ applicants with mobility issues, in accordance with the prescribed social distancing measures to prevent the spread of COVID-19.
